Dear Town of Highland Planning Board.

I would like to begin by thanking you for your decision to require a full EIS for the Camp FIMFO proposal. Your decision ensures the best opportunity for the town to fully comply with state law and to ensure that the environmental and community impacts of Camp FIMFO are fully identified, quantified and considered as part of decisionmaking. The Delaware Riverkeeper Network applauds your decision in this regard.

The key now will be full and fair implementation of that determination and to ensure the Town gets the best information out of this process. With that in mind, the Delaware Riverkeeper Network is urging you to extend the public comment period regarding the Camp FIMFO draft scoping document.

As you know, this is a highly controversial issue that has garnered tremendous interest and engagement from the public. Given the high level of interest, providing only 20 days for the community to fully consider and gather their comments will inhibit many from being able to fully and fairly participate in this important public comment opportunity. In addition, the 20 day period includes days leading up to Thanksgiving when many people will be travelling in order to spend Thanksgiving week with family, which is very unfair and infringes upon the ability of people to fully and fairly engage. The comment period of time that includes the days leading up to, and including, election day – a day when many engaged members of our community are participating in our democracy, including volunteering time to share candidate information and to staff the polls. Given the significant interest and impact of this proposal on the Town of Highland, but also beyond – including neighboring communities in New York and Pennsylvania, as well as having implications for the broader Delaware River watershed region – it is essential that the Town of Highland work to support broad and inclusive engagement.

A robust, inclusive, and fully informed comment process will not only serve the community, but it will best serve the Town of Highland Planning Board and other involved decisionmaking entities. The

Dear Ms. McGil:

Congratulations to the Town of Highland for requiring a full Environmental Impact Statement regarding the development of Camp FIMFO. However, allowing only 20 days for a scoping comment period undercuts the potential effectiveness of the EIS—and a really good EIS is in order for reasons given below.

What's the hurry? As you know, the proposed 20-day scoping period includes the election season and holiday travel days, therefore depriving interested parties the time needed to review and comment on the scoping document. Haste will only serve the narrow financial interests of Northgate, whose environmental concerns regarding the delicate and beautiful Delaware are far down on their list of priorities.

Please use your authority and influence to extend the scoping comment period at least to December 21, 2023, so that the affected community can understand Northgate's proposed project and ask the right questions.

So far, the public that will have to live with Northgate's plan has not been exposed to its realities and people need time to digest and understand what's at stake. Camp FIMFO will not be a pretty dimple on the landscape. If you look at Northgate's YouTube that advertises Camp FIMFO in Waco, Texas, (see <https://www.youtube.com/watch?v=NMg2SL6lvPA>) you will see that their plan for this sprawling amusement park badly needs the scrutiny of an informed EIS.

The plan is obviously and profoundly inconsistent with the atmosphere, natural resources, and purpose of the Upper Delaware. We did not come to live up here to be exposed to another heavy-handed private playground spoiling the natural landscape.

As you know, the Park Service has already determined that Camp FIMFO has a design and purpose inconsistent with the Upper Delaware Wild & Scenic River. Let's take that as a starting point and assure that the EIS is properly informed by allowing enough time for adequate scoping and public comment.

Dear Town of Highland Planning Board,

I write to you from just up-river to thank you for requiring a full Environmental Impact Statement for a possible Camp FIMFO along our beautiful river.

I am very concerned, however, that the 20-day comment period is not long enough for any of us concerned stakeholders to have time to adequately study and comment on the document, especially during the holidays.

The 223-acre planned development would pave over 14 acres of forest at a time when we are all coming to understand the vital importance of the forests to help combat climate change but also to keep the local ecosystems in tact—to keep the water filtered and clean, to support the insects that feed the fish and the birds that bring tourists to our area, to help protect the character of the place we all love so much.

This is not a place for an amusement park with 14 acres of new pavement, lawn and swimming pools—the National Park Service has determined that this proposal is not in keeping with the land and water use guidelines for the Upper Delaware Wild & Scenic River management plan. The permanent structures for guests in the flood plane, the destruction of riparian forest, the increased acreage of impervious surface, and the threats to water quality created by all three are not in keeping with the management plan for the river.

There is nothing wild and scenic about this giant amusement park—the largest development ever in the Upper Delaware, according to a UDC member. Something so unusually large and destructive requires ample time for the community to understand what is proposed and to comment. I ask you to please extend this deadline and give those of us who will be so heavily impacted by this proposed project time to review the Environmental Statement and respond. Please!
