Dear Chairman Sutherland & Planning Board Members,

Subject: Camp FIMFO

Community members have raised many valid concerns about Camp FIMFO. My purpose is not to reiterate those but to raise a sensitive subject that folks may hesitate to bring up.

I was speaking to an acquaintance who lives in Liberty, NY about the proposed FIMFO project. I mentioned to him that the planning board was concerned about what would become of the completed site in the event that FIMFO failed down the road. He answered immediately, as if it were a foregone conclusion, that the Hasidic community would absolutely purchase the site as they have with other properties in the county. He sees similar activity happening in Liberty and feels that Liberty is limited in recourse due to freedom of religion to address any violations.

The discussion brought back memories of when a Chabad center was established in my former neighborhood. Many in the neighborhood considered them to be bad neighbors specifically because they flouted local laws, disrupted the community, and the town was powerless to stop

The following occurred:

- Land with wetlands was purchased and a variance was issued to build a single family house
- Once the variance was issued, plans to build a Chabad that flouted zoning laws were begun immediately
- The Chabad paved over wetlands for parking, opened a school and held events
- The town rightfully issued violations and held a hearing with significant input from residents
- The Chabad's lawyer presented an expert on freedom of religion
- Despite clear and overwhelming evidence of wrongdoing, the EPA and town government quickly folded. The Chabad continues their operations & activities to this day
- This much larger town with 10X the population and significantly greater resources was defeated in their attempts to ensure that local laws were applied equally to all residents

The consequences were:

- traffic and parking became a nightmare, particularly during religious holidays we counted over 60 days of holiday celebrations!
- Congregants, often with baby carriages and big families, who refrained from driving, walked along a dangerous road with no shoulder or sidewalk, often at night and dressed in black.
- The increased traffic and significantly more pedestrian traffic, especially at night, was a big problem for law enforcement and EMS (police were used to direct traffic during events at taxpayer expense)
- The Chabad received a tax exemption and are not paying taxes.

It is not farfetched to imagine that 1) Camp FIMFO could fail and 2) that the Hasidic/Orthodox community could buy or rent it and that some local regulations may not be adhered to. We have seen no business plan or 5-10 year business projections from FIMFO to assure us that their business will be viable in the longer term. Other businesses have struggled here with The Field of Dreams concept: "If you build it, they will come."

- The Resorts World Catskills Casino is failing. I read they were losing \$10MM/mo at one point
- The Catskills Mountain Resort failed as a hotel & restaurant. My understanding is that a religious group leased the property through October of this year, and that group has an option to buy the resort if it can get a special use permit from the town
- Brookwood Camps has been repurposed and was renting to a religious group this past summer
- A property in the Highland Lake community near Hartung Road was sold recently to a religious organization, Beit Tehillah, and they were holding events this Fall.

Is it that hard to imagine that this could happen to Camp FIMFO down the road? It makes sense to look around the corner. Look at the problems and tensions created from the expansion of the village of Kiryas Joel within the Town of Monroe in neighboring Orange County. For context, watch the movie "City of Joel" on Amazon video.

It's clear that the FIMFO project is directly opposed to the wishes of the majority of residents and is poised to ruin the pristine natural beauty of the Delaware River and change the character of our little town. If Camp FIMFO is built and then (likely) fails, there are many options for what could become of the property. One of those options is that another potential bad neighbor could create more headaches like those described above for our community.

Dear Town of Highland Planning Board,

I have lived 30 minutes north of the proposed FIMFO development site for 33 years. I write to ask you to require that a full Environmental Impact Statement be prepared for this project.

The scale of the proposed project and the resulting threats to our natural landscape, wildlife habitats, and water quality warrant a full review and statement. Our local economy depends on the natural beauty and clean water we are tasked with protecting. Reports from other communities grappling with problems caused by Northgate developments are further evidence that a full Environmental Impact Statement is needed.

For example, nearby Gardiner, NY has been fighting to keep Northgate from continuing to expand its "campground." An August meeting concerning Northgate's requests for waivers and special permits for expansion led the town attorney to ask, "At what point is it not a campground?" The <u>local paper reported</u> that the "rhetorical question echoed allegations made by many frustrated Gardiner residents that the recreational facility is no longer a mere campground, but has become a theme park, and a public nuisance, since its 2014 acquisition by Northgate Resorts.

Given that the Northgate Resorts Camp FIMFO proposal will inflict significant environmental and community impact, SEQRA requires that the Town of Highland Planning Board secure/prepare a full Environmental Impact Statement pursuant to SEQRA.

Basing a decision on a mere Environmental Assessment, does not fulfill the legal mandates of SEQRA. Based on what we know to date about the proposed development plans and given the information gaps in what Northgate Resorts has provided, it would be irresponsible and unjustified for the Town of Highland Planning Board to issue a Negative Declaration pursuant to SEQRA.

# Hinsdale officials reject RV park plan, calling it too much for a small town



A national company sought permission to remake Camp Emerson in Hinsdale into a destination for recreational vehicles.



"My opinion on it is that it's not in harmony," he said. "It doesn't keep the small-town character. It doesn't lessen the congestion."

Member Bruce Alexander seconded the motion, and he joined Viner and another member in voting to deny the application. Member Dan Thornton listened but did not vote, because he had expressed opposition to the project before it was filed to the ZBA.

"I don't understand how you can put a development this big in that

area and not have it completely change the character of the neighborhood," Viner said, during a five-minute recitation of his reasons for denying the proposal, which had been the target of vigorous opposition at two previous ZBA sessions, in late November and in December.

"I can't get over the amount of vehicles per day making the trips and just how that alone isn't going to change the character," Viner said. "I can't get over the fact that it's not detrimental."

"Because of these reasons, I'm going to make a motion that we vote to deny Northgate's proposal," he said.

The board must still draft its decision and file it with the town clerk, after which Northgate will have an appeal period.

Midway through the night's proceedings, Viner faced off criticism from a town resident, Walter D. Ulmer, who accused the ZBA of being too cordial with representatives of the applicant. Ulmer said he feared increased traffic on Robinson Road, where he lives, if RV drivers used that as a route to reach Pittsfield.

"You have to let it play out," Viner told Ulmer.

The Hinsdale Zoning Board of Appeals voted unanimously Tuesday night to reject a special permit application filed by Northgate Resort Ventures LLC. The decision ends, for now, more than six months of public debate about the proposal's impact on the Longview Avenue neighborhood surrounding Camp Emerson, and on the town as a whole.

Northgate has a right to appeal the decision. In early December, ZBA members sought, and secured, proof that the town of Hinsdale will defend them legally, if they are named in litigation resulting from a denied application.

"To me, it's a massive, massive development. It would be the biggest development in Hinsdale," said Jeffrey Viner, the ZBA chairman.

The decision is a setback for the Lein family, which reached an agreement to sell the camp it had run for half a century, contingent on Northgate winning approval for its special permit to develop 317 RV campsites on the 155-acre property. The company runs nearly two dozen RV camping facilities around the country, many branded as Yogi Bear campgrounds.

Sue Lein was one of more than 60 people who watched Tuesday's proceedings via a Zoom broadcast, while an additional 20 or so observed from the auditorium of the Nessacus Regional Middle School in Dalton.

Just before 8 p.m., after 90 minutes of additional evidence collection, Viner moved to reject the application. He did that after reviewing the town's relevant bylaws, one of which states that a special permit application must be in harmony with the town's character.
