Our allocation from the Sullivan County Youth Bureau was reduced this year to \$7,500, that was the initial payment that we made and we are putting together a meeting with the representation from Koinonia to look at additional disbursements that we could make relative to their funding request. Emergency Management

Councilwoman Haas/Councilman Tambini report: We did put out a press release with a joint press release with the Sullivan County Sheriff's Department relative to some threats that were made. There was some back and forth and some of the different press releases because it's not that the threats were unfounded. They were actual threats that were made. They were just not credible because of the evidentiary findings of the sheriff's department's investigation and visiting with that youth to separate into separate locations. The school opened on time they did have additional sheriff's deputy to assist the SRO who is assigned to the Junior Senior High School. They also have a contract with the elementary school for a school resource officer. Those are both sheriff's deputies that are in the district full time. They did send additional resources down for the first day of school.

Supervisor Haas reports: We're just waiting on the Swift plan and then we'll resubmit to our consultants and hopefully the state will come through for us as anticipated.

Insurance

Supervisor Haas reports: I met with our insurance provider Chris Slonaker from Nymer. We met for several hours going over the town's portfolio, insurance portfolio, adjusted some values of some of the buildings went over the inventory of the highway department and vehicles and current staff. He will be getting back to us with a report as well is what is going to cost us for next year. We went up on some things we went down, eliminated some vehicles, which really helps taking them off the policy so we don't have to pay for stuff that just basically sit around but still needs to be insured. We're probably looking at three to four percent right there.
