HIGHWAY

Supervisor Haas states the highway department has been out paving and Chip sealing our roads they've previously paved in last year to approximately six or seven miles of road, lane miles would double that. They are winding down their work season for this year. They will be concentrating on snow removal, which is be forthcoming very soon, probably. The highway department had a very busy year and they've accomplished a lot of projects. As of now there are no new updates in the delivery of the various trucks.

SUPERVISOR

Supervisors report we are into budget season, the board members have had the tentative budget in front of them for about a week and a half now. They've been perusing it and we will be scheduling our first Workshop for Thursday night at seven o'clock. Our workshops normally run between an hour to two hours. The budget tentatively stands at a 9.87% increase which will be paired by this board down to where the governor's 2% is acceptable. As I have done and this board has done for the past eight years, we've kept reasonable budgets so there's very, very little strain on our tax base. In we always try to match the rate of growth with the percentage increase in the budget. We are negotiating a highway contract. We will be negotiating that hopefully by the end of the month, then those numbers will be interjected into this budget also. Those negotiations will start after the 16th and negotiating team will be meeting with the union or the highway department and we will be moving forward for a contract. **PUBLIC COMMENT**

John Pizzolato asks: With the negotiating team that's doing the highway department. I'm just curious, why is it an outside team outside of the town board? You know, I was at the meeting a couple Fridays

ago where you picked Michael Davidoff. Supervisor Haas responds: in years past we've hired an Albay firm to do or negotiate with the highway department, they cost us a lot of money. Jimmy Gutekunst and Jimmy Hansen were the last ones to negotiate the highway contract with the Albany Law Firm that negotiated for us. Jimmy G felt like he was able to negotiate that and Michael Davidoff stepped forward he said I would like to be on a negotiating team too.

COMMUNITY PLANNIN SENIORS

Councilman Bosch reports: The meeting went well and we had several candidates speak at the meeting. **YOUTH & PARK DEVELOPMENT**

Councilwoman Haas/Councilman Tambini report: We made our second disbursement to our community partner Koinonia for \$10,000 to support the summer youth programs, the total expenditure for that program on the Town of Highland which did not include any taxpayer dollars was \$17,500. I did submit the paperwork for reimbursement from the county for the county's \$7,500 commitment and award through the youth program. They said our paperwork was so perfect that they use it as the example in the YouTube video on how to complete it.

Peter Carmeci reports: We will be holding our Veterans Day Ceremony on September 11, in Hero's Park.

Councilwoman Haas talks about the fiscal stress designation and NYCLASS:

We can just give a review of what we did send out as a we did it as a press release. The state comptroller's office in created a rubric we submit information to, it standardized most of the towns, villages, the county school districts participate throughout the state and the information, which is all budgetary information, expenditures, balances risk is fed into the system. They then produce a fiscal stress score or rating based on the information that you've provided. For the second year in a row, so for 2021 we had a 0.0 score, which is no designation and 2022 we also had a 0.0 score no designation meaning that there's no fiscal stress impacting the town. This is based on the again the Comptroller's fiscal stress monitoring system. The information is their review of our 2022 annual financial report that we complete based on our budget, budgetary expenditures, account balances and revenues. It's something that we as a Board have focused very highly on, it is not bonding out things to be expensive for the future. Taxpayers, expending monies wisely, but while making sure that the essential services and supports are in place. The highway equipment replacement plan that we're on has us replacing the large vehicles and the small vehicles, a schedule that doesn't create increased maintenance needs, and expenses and provides our highway department with really safe and functional equipment to complete their jobs. It's a lot of work. We do spend a lot of time on the budgets and expenditures but it has been paying off, we've also stayed under the tax cap.
