HIGHWAY

SUPERVISOR

Fred Bosch and I went up to the highway department today, to thank the highway department for the job the that they did on the stormwater protection plan project that we had needed to complete the town highway shop and salt shed capital improvements. It looks very good. Not quite finished yet because they ran into poor weather and it'll be finished off in the spring with some more sealing and a little bit more dirt to be added. It goes without saying that I thoroughly enjoyed this job and I'm going to miss it.

PUBLIC COMMENT

When it gets down to the proposed resolution for concerning account verification, we'll go into a little bit of what it means by the records are reasonably accurate. What happens when supervisors change, we have the accounting department go through our books and it's called a company agreed upon procedure. We've had some discrepancies over the years and they're just going to look at everything, make sure everything is okay. The audit process that we have works very well for the bills but there isn't an auditing process for the payroll as the bookkeeper just takes care of that herself. So that would be the only place that really needs an audit and a look at. We've hired our consultants, our accountants, I should say, that we've used for the

last 20 years to do that for us again. And what they do is they basically look at laws, look at the controller's reports moving forward to make sure that we're doing everything within the letter of the law. And that's how we deal with change. The town board can request an audit at any time. But it's a wise idea to do it when you're changing town supervisors.

John Pizzolato: straying slightly off the agenda I would like to thank you for your years of service. I'm a little concerned with some of these appointments. As we're moving into the reorganization for January 2, I've already had a conversation to set regarding the town historian position considering we're working with a lot of historical markers and other projects that were initiated by Debra Conway who's been amongst the town historian because the institutional knowledge for all those historical placards. I will be reassigning somebody as of January. And I'm concerned that every other view or his name committees like the Sullivan County Fire Advisory Board, the town historian, it's not it's insignificant because it's something we would obviously do to work with the Humane Society of Port Jervis. But I'm wondering why you're waiting until the final month of December to jump the gun of reorg and assign people in December when those things should have been done in January. Supervisor Haas: what we had is Timothy Oset was working through his work environment to make sure he had clearance to be able to do this through the park service. This process actually started in July for town historian and it finally came to fruition in early November and we just missed it on last month's agenda or would have been done last month, as far as the fire Advisory Board member that is always appointed in December because they need it for the roster January first. So that's always done in December, and you can look back at past minutes of years past and you'll notice that the fire Advisory Board member is always appointed in December, reappointed again in the reorganization meeting. It should be on the list for the reorganizational meeting also. Yes. And the way the fire Advisory Board Member works is it's a trade- off between both fire departments normally Yulan fire department will do it for a couple of years and then Highland Lake Fire Department will put forward a nominee and Highland Lake Fire Department will send a fire Advisory Board member to the county to participate in the meetings. This would be Dave Preston's second year. After this it would probably revert back to the Highland Lake fire department and they would put forward a nominee and the board would probably nominate that person.

COMMUNIUTY PLANNING/SENIORS

Councilman Bosch: the seniors had a nice meeting and a successful annual Christmas party dinner and they have suspended all meetings at the senior center until March so that the seniors aren't coming out in a storm or having to return during the storm.

YOUTH & PARK DEVELOPMENT

Councilwoman Haas: We submitted all the documentation for the summer youth program for the county. They have not yet released the RFP for the 2024 program. We anticipate it will be the same or a similar process as it has been in years past.

I'm pleased to announce that as a result of the town highway department completing the Swift plan. We had submitted paperwork to the State DEC for our final payment. I made about eight phone calls to

different representatives in the DEC finally got the guy that I needed in the water department that puts the checks forward so someone further up the line can sign them and he's going to push that request forward. Hopefully we'll have our check by the end of the year. And that check will total \$112,015 So that was very soon, very shortly needed money to complete that whole grant and that whole grant will be totally finished.

If one Councilman or the supervisor should get sick, or something worse happen and not be able to make a meeting this town would almost cease to function. Moving forward, I think we need to appoint a council position tonight. Someone to fill the council position until the next election.

Town Attorney Michael Davidoff states you have a perfect right as soon as the resignation was submitted to the clerk automatically creates a vacancy, which can be filled by this point.

John Pizzolato: As the election was very decisive for new leadership, I would ask that you would wait until the new year to fulfill those positions. There's three people on the council now including yourself, and there's two incumbents coming in. We have four total that will be present in the new year when the new cycle takes place. But I feel like the voters made their decision for what direction they wanted the town to

go in and it doesn't include last minute appointments by anybody. It doesn't feel like it's a very like inclusive of the town's wishes and the wellbeing of the town and the will of the voters. So, I would ask that you would wait till the New Year or assume the position yourself until the new year so we can appoint somebody as the new board that was duly elected in record numbers. You've been operating without five since ... Jeff states we've been operating what was been operating without five but we're down to three right now. Right? In the absence of one of the council seats right now this town board could not function. John asks Mr. Davidoff is there like a requirement to have five or four at all times as law? But there's nothing that is problematic because, it is problematic because the voters voted against this regime. I mean, it's no different it's a movement. Mel Carney: the current supervisor has the right to appoint the attorney just said and I think that's what they should do. John: the current attorney the attorney who works for the town board and there's a new incumbent town board that's coming in right and when it does

There's a new board coming in. So, there's three new town board members. So now we're going to cut in volumes of up to like the positions from the top 58% for the supervisor 57% for the...

Councilwoman Haas makes a motion to move forward with that appointment, seconded by Councilman Bosch. All in favor, aye. All against and that's unanimous. You didn't have a name yet. Okay. At this time. Do we have a candidate that you would like to move forward? Councilwoman Haas: I'd like to make a motion to appoint Jim Akt as the Councilman replacement. Councilman Bosch seconds the motion. Supervisor Haas: the motion was made and seconded to appoint Jim Akt as Councilman to fulfill the term of Chris Tambini until the next election would be a roll call vote. Jim Akt do you accept? Jim Akt accepts and states the he has more than 12 years under his belt, more than a lot of these guys around here. I'm willing to help out anytime I helped out in both towns. Committee wise, community service anything you guys need help with I'm more than happy.

Town Clerk takes roll call: Councilwoman Haas, yes. Supervisor Haas, yes, Councilman Bosch, yes. Town Clerk than swears Councilman Jim Akt into the Town of Highland Town Board. Thank you, Jim please take your seat on the board.

Supervisor Haas is there any other new business coming before the board? Moving forward we will move on to proposed resolutions.
